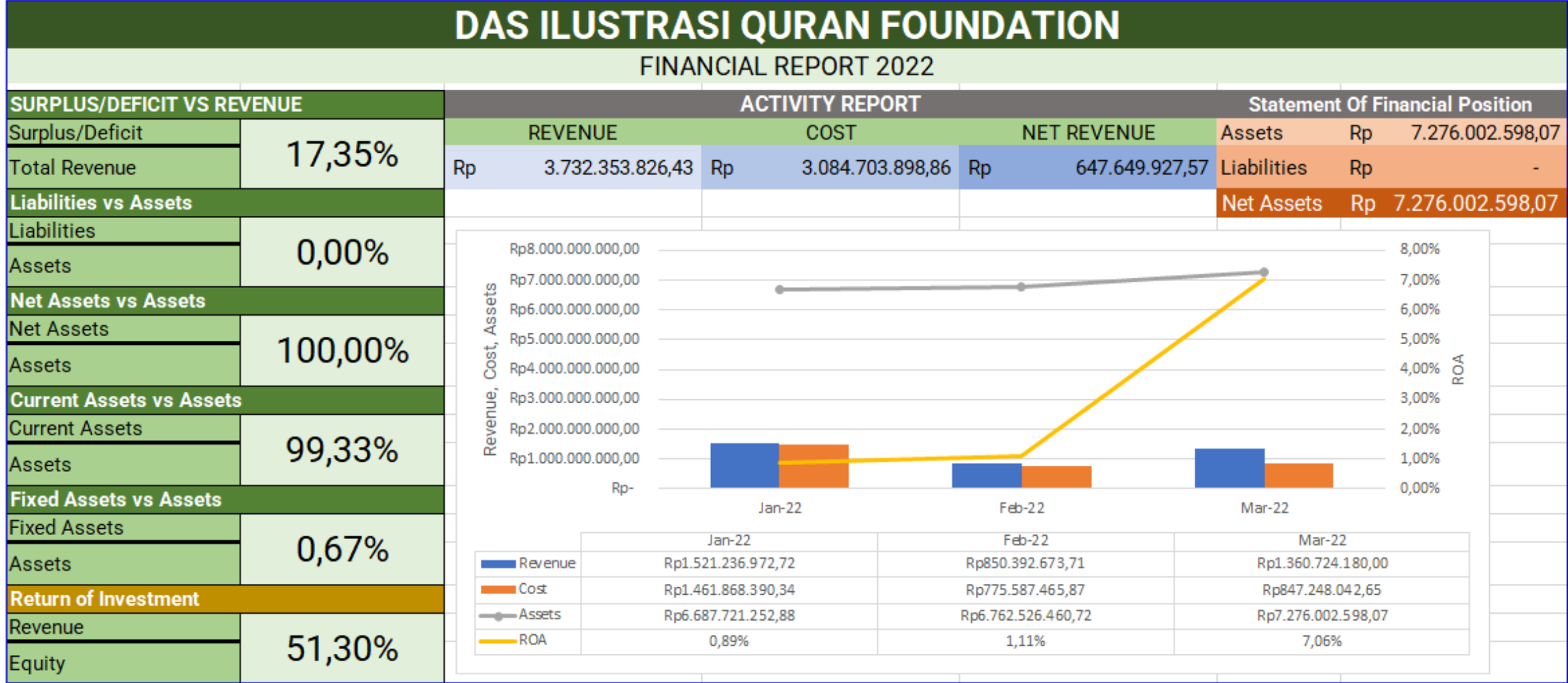

- Internal expenses are costs incurred from the domestic payment system
- External expenses are costs incurred from foreign payment system
